Access to Justice of Persons with Disabilities: the way forward and practical tools

Context

Persons with disabilities experience higher rates of discrimination and rights violation than persons without disabilities, moreover their disproportional presence in the mid-to-low income categories and the inaccessibility of the judicial system aggravates this situation. Given that access to justice is both a fundamental right and a precondition for other rights it is crucial to address the barriers that they face.

This webinar will bring together support legal practitioners, service providers, trainers, academics and organisations of persons with disabilities to discuss:

- to discuss the context of Art. 13 of the UN CRPD and of Art. 26 of European Charter of Fundamental Rights to support access to justice for persons with disabilities
- to exchange and analyse the main legal, bureaucratic, practical issues hindering access to justice for persons with disabilities
- to present the MOOC training addressed to legal practitioners to better support persons with disabilities in their access to justice
- to discuss the needs and the way forward to ensure more equal justice systems in Europe.
